Sub: Prime Minister' Research Fellows (PMRF)-reg.

This is with reference to D.O. No.35-3/2018 –TS-I dated 23rd August, 2019 received from Secretary, Ministry of Human Resource Development, Department of Higher Education, Government of India, New Delhi and informed that the Government of India has launched the Prime Minister' Research Fellows (PMRF) in February, 2018 with the objective of attracting meritorious students From IISc, IITs, NITs, IIITs and IISERs to pursue Ph.D programmes in IISc Bangalore, IITs and IISERs with attractive rates of fellowship ranging from Rs. 70,000/- to Rs 80,000/- per month in addition to an annual Research Grant of Rs. 2.00 lakh per student for five years. The guidelines of PMRF were revised to make the scheme more inclusive by allowing students from all recognized Higher Educational Institutions (HEIs) in the Country to apply under the Scheme. Further, it has appraised that, in the three calls of proposals they have had so far, only 295 fellows have been selected as against the envisaged target of 3000 fellows over a period of three years.

In order to attract good number of meritorious students to join PMRF Scheme, you are requested to apprise & motivate all the faculty members in your Department/ Centers/ Institutes to identify potential students in final year, having at least 8 CGPA, and mentor and guide them in preparing projects/abstracts so that they are able to meet the selection criterion. Further, each University /Institute /Centre may include the number of students mentored and selected into the PMRF Scheme as one of the performance parameter in the MoU Which UoA is required to enter into with MHRD each year. (Copy of the D.O. letter is enclosed for ready reference).


