Terms and Conditions:

1. Unsealed & conditional tenders shall not be accepted.
2. Bidders are required to deposit the tender fee slip of Rs.500/deposited to university account office as cost of tender form.
3. Bidders are required to deposit 2% of estimated cost of the work as Earnest Money in form of Demand draft/FDR in favor of Finance Office, University of Allahabad, Allahabad.
4. The University reserves right to reject or accept any or all the tender without assigning any reason thereof or to distribute the whole work between two or more contractor/firms.
5. Rates shall be valid for 90 days from the date of opening of tenders.
6. Taxes shall be deducted as per rules.
7. Your rates should be inclusive of all taxes.
8. The payment of wages/ allowance and other benefits admissible including safety to persons employed by the contractor for the job shall be the sole responsibility of the contractor as their employer under law.
9. The contractor shall be legally liable and responsible for any contravention of any legal requirement and consequent liability with regard to persons deployed by him in connection with the work assigned to him by The University.
10. In case of any dispute the decision of the Vice-Chancellor, Allahabad University shall be final and binding on both the parties.
11. All the litigations will be subjected to the jurisdiction of courts at Allahabad.
12. In case the work is not completed in stipulated time penalty of 5% of the value of work will be deducted from the contractors bill subject to maximum of 10% of total amount of bill.
13. Standard deductions as per rule will be made from the bill.
14. Work will be carried out as per standard specification CPWD/PWD/BIS etc & good practices of construction/maintenance.
15. Defect liability period for the work will be 12 months from the date of completion of the work.
16. The bidder shall sign all the pages of tender document.
17. The bidder will submit requisite no. of the photographs of the site before starting of the work and after completing of the work, in case the work is awarded to the bidder.
18. Bidder should attach experience certificate of similar nature of works carried out during the last five years.

1	<p>Supply, installation & finishing of Air-Cush wooden sports flooring system confirming the requirements of WSF consisting of:</p> <p>The Surface Board: Kiln seasoned imported Maple wood (Sycamore) surface board finished with 21 mm thick, 50 to 110 mm width and in random length in tongue and groove shape. The edges of the boards will have a finger lock groove and the bottom side with air pass groove.</p> <p>The Under Frame: Made of commercial quality Fir/Spruce/Pine wood runners of 90/70mm X 45mm treated with anti-termite solution and fixed on the bottom side with 18mm thick air-cushioning pads by nails through the two wings at 350mm c/c.</p> <p>The Installation: The surface boards will be screwed to the runners through the tongue only and will lock the screwed tongue by the groove of the adjoining boards. The ends of the boards will be locked by inserting the wooden fingers through the edge grooves and fixed with suitable adhesive. An expansion gap of 8 to 10mm will be left open between the wooden flooring and the surrounding tiled area/wall.</p> <p>The Finishing: After Installation, the floor will be machine sanded in uniform level and finished with imported non-skid DIN certified polyurethane lacquer. Game line marking will be carried out in required colors before applying the finish coat.</p> <p>TIMBER:</p> <ol style="list-style-type: none">1. The timber used for surface boards will be imported Hard Maple (Sycamore) wood.2. All timber will be free from loose knots, bee or borer holes splits, cracks and fungal attack.3.
