Initially, the awardee is to register at Scholar's Corner available at Scholarship & Fellowship Management Portal (SFMP) (https://scholarship.canarabank.in/). The Universities / Institutions will link the data of the awardee with the Master Data on the SFMP with their unique Maker and Checker IDs. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the awardee on monthly basis. Based on the data updated on SFMP by the concerned Universities / Institutions, the payment of the fellowship will be made to the awardee.

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on https://ugcnet.nta.nic.in. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
