NOTIFICATION

In continuation to our earlier Notice No. 05/R/145/2020, dated 16th March, 2020, the following decisions are being announced for strict compliance with immediate effect in the light of the Advisory of Ministry of Health and Family Welfare, dated 13.03.2020, the Advisory of State Government dated 17.03.2020 and the Advisory of the MHRD with regard to COVID-19 (Corona virus) disease:

1. Teaching in the University/Constituent Colleges shall remain suspended until March 31, 2020.
2. The ongoing Under Graduate examinations between March 18-31, 2020 are deferred until further notice. Examinations from April 01, 2020 shall continue as per announced schedule. The schedule for examinations deferred during March 18-31, 2020 shall be announced later.
3. All students are advised to return to their homes and take adequate precautions as per Guidelines issued by the Government of India. The students are also advised not to huddle in a group anywhere.
4. All Conferences/Seminars/Workshops, Cultural activities, meetings etc. on the campus during the above period would remain cancelled.
5. All common facilities like Central Library and Departmental Libraries etc. will remain closed till March 31, 2020.
6. If any stakeholder has a travel history to any COVID-19 affected place or has come in contact with such persons, it is advised that he/she should inform Chief Medical Officer (CMO) so that they can be monitored and taken care of if need be.
7. Proper sanitization needs to be ensured on daily basis at all places in the Departments/Units. The Wardens/Superintendents of all the Hostels need to ensure that proper sanitization is done on daily basis at all the places, particularly such places which are frequently visited by the students.
8. All Faculty members, Officers and staff shall continue to attend to their duties and responsibilities. Routine office work will remain unaffected during this period.
