Resolution No.02/55 The "Action Taken Report" in pursuance of the decisions taken in the meeting of the Executive Council held on 08-03-2019 (regular) was presented by the Registrar. At SI. No. 12 of the ATR relating to Agenda No. 12/54, the members wanted to know the fate of the CCASH Committee Vice Chan Report on the complaint filed by Dr. Alka Prakash against Dr. Surya Narayan Singh, Associate Professor, Department of Hindi, University of Allahabad. Prof. Sangita Srivastava, the CCASH Chairperson, who was present in the meeting as a Special Invitee, was requested by the Chairman to respond to the query of the members. She informed the members that Dr. Surya Praity of Narayan Singh was asked a couple of times to appear before the Committee but he failed to appear. He availed the last opportunity when the necessary copies of the documents were given to him and he had promised to file within few days the written rebuttal/his version supported by documents and witnesses. They were thoroughly discussed and all the the recommendations made by the Academic Council vide its Resolution No. 05/35 were unanimously approved except the counting of the teaching experience rendered as a Guest Faculty as it was not found to be logical and in consonance with the rules. It was also resolved to advertise the faculty positions (with EWS Reservation for the post of Assistant Professors/Assistant Librarians only in the light of Govt. of India Policies and Guidelines). It was further resolved that 1:10 would be the ratio for calling the screened candidates for Interview for each post. **Resolution No.09/55** Prof. Man Mohan Krishna spelt out the objects behind the proposed amendments in the above Ordinances. He added that the amendments were necessitated by certain changes that had taken place since the first

Ordinances were framed in 2008 and amended in 2016. The important changes were the introduction of teaching of Postgraduate classes in the Constituent Colleges in 2016, the permission of research guidance for the teachers of the Constituent Colleges granted in 2018 and there being no more any Government College as a Constituent College of the University and they had necessitated the proposed amendments. It was also pointed out that the UGC Regulations framed in 2010 were amended in 2013, 2016 and then in 2018. These changes had necessitated the amendments in all relevant Ordinances. He further informed that as a sequel to all the above reasons, the Executive Council in its meeting held on 8<sup>th</sup> March, 2019 vide Resolution No. 04/54 had approved wide ranging amendments in Ordinance LVI: The Doctor of Philosophy Programme. The Executive Council had already resolved in its meeting held on 20<sup>th</sup> December, 2018 vide Resolution No. 07/53 to adopt and incorporate the Office Memorandum No. F No. 14014/02/2012-Estt.(D), dated 16-12-2013 in Ordinance LXV: Appointments on Compassionate Grounds. Similarly, amendments in other Ordinances, arising out of these reasons, were in the process and they would be placed before the Executive Council in due course of time. With these reasons and objects he presented the amendments as duly approved by the Academic Council vide its Resolution No. 13/35.

After due consideration the proposed second amendments (2019) in Ordinance XXXV: Constituent Colleges, Ordinance XXXVIII: Selection and Appointment of Teachers (including Principals) in the Constituent Colleges, Ordinance XLVI: Career Advancement of Teachers of the Constituent Colleges, Ordinance XLIX: Classification and Appointment of the Non-Teaching Staff of the Constituent Colleges, Ordinance LXV: Appointments on Compassionate Grounds and Ordinance LII: General Provisions of Admissions were unanimously approved. Thus, since 2008 the University of Allahabad was without the mandatory NAAC Grading. The members were informed by the Chairman that the University had fallen short by only 0.1% to get the "A" Grade and our shortfall was accentuated by the large number of teaching posts lying vacant

due to reasons beyond the control of the University. We had enviable record so far as the project grants, infrastructure and the buildings were concerned.

The members of the Executive Council unanimously applauded the Vice Chancellor on his administrative resolve to get the NAAC ranking. The members recorded it with deep sense of gratitude to the Vice Chancellor that his firm resolve and purposeful leadership galvanized the University teachers, students, employees and the officers to work tirelessly to raise the NAAC Grading. In the background of the legacy of over-all indifference and a general sense of apathy prevailing on the campus for a period of more than ten years since 2005, the bagging of B++ NAAC Grading was a great and commendable achievement.
