The Chairman informed about his meeting with the Deans along with Registrar, Finance Officer, Proctor and Public Relation Officer on 8th November, 2011 on the issue to discuss the roadmap for celebrating the Ouasquicentennial Anniversary wherein it was decided to constitute Ouasquicentennial Cell in the Chairman-ship of Prof. N.R. Farooqi, Dean, Research & Development, Dean, College Development, Dean, Students Welfare and Deans of the Faculties to be part of the Cell. The Cell will chalk out various programmes to be organized at Departments as well as the University level and also to suggest the roadmap for planning and executing these programmes with the help of various officials / sub-Committees. With regard to the Convocation and Investitures of University of Allahabad, the Ordinance LXII provisions for such arrangements and enshrines for stipulation of First Regulations for holding Convocation/Investitures to be drawn by the Vice-Chancellor and shall be reported to Executive Council. For this purpose a Committee consisting of all the Deans under the Chairmanship of Prof. N.R. Farooqi is constituted. The Committee is requested to do the needful at the earliest.
