Note: The Academic Council in its meting held on 27-08-2011 vide Resolution No. 12/07 constituted a Committee.

(Report of the Committee is circulated)

- Resolution No.01/11 The Academic Council deliberated the issue at length and resolved that the 'Admission Regulations 2012' of the University of Allahabad be adopted and implemented from the Academic Session 2012-13 with the following modifications by addition:-
 - (1) In the last line of Rule No. 1 (ii), after the word by "UGC Regulations, University Ordinances and," the words may be added.
 - (2) In the third line of the Rule No. 5. (a), the word "during" be replaced by the word "at".
 - (3) In the fourth line of the Rule No. 5 (b) (iii), after the word "Department" "independent may be added before Centre". And after the word "Centre", the words "Director, Constituent Institute/University Institute" may be added.
 - (4) In the tenth line of Rule No. 9, after the word "Unit", the word "Sub-Unit" may be added and in the proviso after the word Unit "Sub-Unit" may be added in all the places. Further, in note no. 2. after the word "Unit", the word "Sub-Unit" may be added in all the places.

One of the Hon'ble member expressed note of dissent in the matter.



Any other Item with the permission of the Chair:

The Chairman raised the issue of Common Semester Rules for various Examinations. After discussions, it was **resolved that** the Vice-Chancellor be authorized to get prepared by a Committee, the Common Rules for various Courses run under the Semester System of examinations.
