NRI Ward/Sponsored Category Admissions 2024-25 Now Open

- The University of Allahabad is pleased to announce the inclusion of the NRI Ward/Sponsored category in its updated admission guidelines for the academic session 2024-25. This category, introduced under the "International Students Admission Rules & Procedures 2024" provides exclusive admission opportunities for the wards of NRIs and sponsored candidates, facilitating their enrolment into the university's academic programs.
- A maximum of five (05) supernumerary seats have been allocated specifically for NRI Ward/Sponsored category admissions across all courses and programs offered by the University, except for Ph.D. programs. This provision is applicable solely for the 2024-25 session. Candidates under this category are required to pay fees equivalent to those applicable to Foreign Nationals under the self-finance category.
- Admissions will be granted based on the merit of the qualifying degree. No application processing fee is required. The application form, along with the required annexures and fee structure, is available on the University website at https://www.allduniv.ac.in under the heading "NRI Ward/Sponsored Category Admissions 2024-25"
- Applicants must ensure that their parents or sponsors hold valid NRI/OCI status at the time of admission. Additionally, they are required to submit a duly filled Sponsorship Form and a Declaration by Sponsors along with their completed application form.
- Scanned copies of the completed application form and the required supporting documents must be submitted via email to: international students office@allduniv.ac.in no later than 11:59 PM (IST) on 23rd October 2024.

APPLICATION GUIDELINES

- 1. The NRI Ward/Sponsored category candidate seeking admission to a course/programme at the University of Allahabad is required to send his/her application in the prescribed application form. The duly filled application form together with relevant documents must reach at University not later than 23rd October 2024. The scanned application form must be sent via email along with the self attested scanned copies of relevant documents/certificates to internationalstudentsoffice@allduniv.ac.in not later than 23rd October 2024.
- 2. The committee duly constituted by the Honorable Vice Chancellor of the University will meet to finalize the admissions, and successful candidates will be informed via email. Upon receipt of the admission offer letter, the candidates must submit the original documents to the Office of the International Students Advisor and confirm their acceptance by promptly paying the fees as per the prevailing procedures of the University.
- 3. Application Form should be filled legibly in English by the candidate in his/her own handwriting.
- 4. The applicant should write his/her name, father's name, mother's name as given in the school certificate of Board/University.
- 5. No column should be left blank in the application form. Incomplete application forms will be summarily rejected.
- 6. Photocopies of all the required documents/certificates and copies of syllabi as mentioned in the application form should be enclosed. If admitted, the student will be required to produce original certificates/documents at the time of taking admission to the University.
- 7. Mere submission of an application form does not guarantee admission.
- 8. All admission offers are provisional.
- 9. Candidates under this category are required to pay fees equivalent to those applicable to Foreign Nationals under the self-finance category. The fee refund policy, re-admission policy, and all other related policies will follow the prevailing practices of the University. However, the registration fee is non-refundable.
- 10. Applicants must ensure that their parents or sponsors hold valid NRI/OCI status at the time of admission. Additionally, they are required to submit a duly filled Sponsorship Form (Annexure C) and a Declaration by Sponsors (Annexure D) along with their completed application form.
- 11. English and Hindi are the medium of instruction at the University of Allahabad, and hence, a good command of the language is essential for the successful completion of the course.

- 1. The last date for receipt of the application form via email for admission consideration is 23rd October 2024.
- 2. In case any information furnished in the application is found to be false or incorrect, at any time during or after completion of the program, the university reserves the right to cancel the admission and take other steps as may be deemed fit.
