F.No.32-9/2014-Desk (U) dated 29-08-2014 of Shri Surat Singh, Deputy Secretary to the Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi.

- Note:(1) As per MHRD letter no. F.No.32-9/2014-Desk (U) dated 29-08-2014, the Hon'ble Visitor accepted the resignation of Prof. Anil Kumar Singh, Vice-Chancellor, University of Allahabad, Allahabad. Alternative arrangement against the vacancy caused shall be as per provisions mentioned in the Statute 2.(6) of the University of Allahabad Act, 2005.
 - (2) As per the Clause 2.(1) of the Statute of University of Allahabad Act, 2005, the Vice-Chancellor shall be appointed by the Visitor from a panel of not less than three persons who shall be recommended by a Committee as constituted under Clause (2).
 - (3) As per the Clause 2.(2) of the Statute of University of Allahabad Act, 2005, the committee referred to in clause (1) shall consist of three persons, out of whom two shall be nominated by the Executive Council and one by the Visitor and the nominee of the Visitor shall be the convener of the Committee :-

Provided that none of the members of the committee shall be an employee of the University or an institution maintained by, or admitted to the privileges of, the University or a member of any authority of the University.

Resolution No.12/28 In pursuance of letter no. F.32-9/2014-Desk(U) dated 29-08-2014 of Deputy Secretary to the Government of India, MHRD, Department Higher Education, New Delhi, Under the provision of Clause No. 2 (2), of the Statute of the University of Allahabad Act, 2005, the Secretary apprised the Council that two persons are to be nominated by the Executive Council for the constitution of the Committee for appointment of the new Vice-Chancellor.

> After thorough deliberation for nomination of two persons as nominees of the Executive Council under Statute 2(2) of the Statutes of the University for constitution of the Committee for appointment of the Vice-Chancellor, the members arrived at consensus.

> Resolved that (1) Prof. Sudhir Kumar Sopory, Vice-Chancellor, Jawaharlal Nehru University, New Delhi and (2) Hon'ble Mr. Justice R.S. Dhavan, Former judge, The High Court of Judicature at Allahabad (U.P.) & Former Chief Justice, The High Court of Judicature at Patna (Bihar), be nominated Search Committee member for the appointment of the Vice-Chancellor.
