So far as the case of the promotion of Dr. Rajeev Singh is concerned it was found that the Screening Committee has mentioned as under :-

"The case of Dr. Rajeev Singh, Department of Electronics & Communication regarding applicability of A.P.I. Score as per U.G.C. Regulations is pending before the Hon'ble High Court where he by means of a writ petition has challenged the applicability of A.P.I. Score for being promoted on the post of Professor in the Department of Electronics & Communication, University of Allahabad. The Screening Committee could not recommend his case as his A.P.I. score was not in accordance with the U.G.C. Regulations prescribed in this regard. The case of Dr. Rajeev Singh was considered along with similar case of another teacher of the Department of Electronics & Communication namely Dr. R.S. Yadav and it was decided that they may be allowed to appear before the Selection Committee for interview and they were called to appear for interview before the Selection Committee to defend their case and prove their suitability for the post of Professor under Career Advancement Scheme."

Therefore, Dr. Rajeev Singh and also Dr. R.S. Yadav were called to appear before the Selection Committee. The Selection Committee after going through their research work did not recommend Dr. Rajeev Singh and Dr. R.S. Yadav for promotion on the post of Professor without any speaking order.

It was resolved that the recommendations of the Selection Committee be approved for the above candidates. When the recommendation for the post of Professor in Department of Physics was being taken-up it was found that dates of eligibility of Dr. Phool Singh Yadav and Dr. V.K. It was resolved to refer above five cases to the Hon'ble Visitor as the Selection Committees have not given its opinion through a speaking order. It was also decided to send the recommendations and comments of the Selection Committees in the above cases along with all the relevant material/documents to the Visitor as per the provisions laid down in Clause 15.(6) of the Statute of University of Allahabad Act, 2005 and the Clause 7.(f)(ii) of Ordinance XLV.

To consider the order dated 29-10-2015 in the Contempt Petition No.3993 of 2015 of Hon'ble High Court (Shefali Nandan Vs. Prof. N.R. Farooqi & other) under the item with the permission of the Chair.

Resolution No.02/36 The Registrar reported the order dated 29-10-2015 of the Hon'ble High Court in Contempt Application No. 3993 of 2015 (Shefali Nandan Vs. Prof. N.R. Farooqi & other) wherein the Hon'ble High Court while agreeing that the order of the Writ Court should be observed in its spirit directed that "It is expected that by the next date fixed in case any meeting of the Executive Council take place all efforts will be made by the opposite party to comply with the order of the Writ Court".

> As the discussion started one of the members of the Executive Council Prof. C.L. Khetrapal reiterated his earlier stand taken by him over the matter in the meeting of the Executive Council held on 22-06-2014, 05-07-2014 and 20-09-2014 and got his opinion recorded as under :-

"The envelopes were not opened earlier because of improper selection of experts. In view of the Hon'ble High Court Order dated 29-10-2015 (Shefali Nandan Vs. Prof. N.R. Farooqi and others) that "It is expected that by the next date fixed in case any meeting of the Executive Council take place, all efforts will be made by the opposite party to comply with the orders of the Writ Court" the envelopes were opened in the meeting of the Executive Council held on 07-11-2015 and it was resolved to refer the matter to the Hon'ble Visitor providing all the facts."

However another member Prof. Rakesh Khanna, Dean, Faculty of Law reiterated his earlier stand taken by him in the aforesaid meetings & insisted that since the Executive Council has resolved earlier and considered the recommendations of other departments and also of CAS cases in several departments of the University whose envelopes for cadre posts were to be opened & considered, the recommendations beapproved & appointments be given otherwise it shall amount to Contempt of Court, as University can not apply different standards in different cases as the process of selections

were same in all the cases. He further stated that as no issue was raised at the time of interview or till three envelopes of Commerce Department were opened in the Executive Council meeting dated 22-06-2014 but the objections were raised at the time of openingthe fourth envelope, of Assistant Professor of Commerce Department. There is also no dissent of any member of the Selection Committee in the recommendations regarding the names of experts or their academic eminence, the recommendation of the Selection Committee be accepted and appointments be given to the selected candidates.

The members agreed to open the envelopes in compliance of the High Court order however no consensus could be arrived regarding the acceptance of the recommendations. After thorough discussion and deliberations as no consensuses could be arrived at the Chairman requested the members to give their individual opinion in writing so that the majority opinion may be ascertained. Thereupon, individual opinion of members was taken and the result is as follows:
