The retired High Court Judge would also look into other financial or administrative irregularities conducted by any other teaching or non-teaching staff members while holding any administrative position in the University of Allahabad. The report by retired High Court Judge would be presented to the Executive Council from time to time.

> It was also resolved that the Report of CCASH Committee dated 16-03-2016 was placed before the Executive Council along with appeal alleged to the filed by of Ms. Deepshikha Sonker under section 18 of the Sexual Harassment of women at work place Act No.-14 of 2013 read with the Allahabad University Statute 10(2) and Ordinance XLI- 7(h) of Allahabad University Act 2005. Dr. Sangita Srivastava, the Chairperson of CCASH was invited to explain all the queries raised by the Hon'ble members regarding its constitution and method of enquiry conducted by it, along with the competency of its of members. Prof. Sangita Srivastava presented all details of the enquiry and then Executive Council unanimously approved the constitution of the Committee as well as the whole Report submitted by her on 16-03-2016 signed by all the members, expunging the line "that the Department of Economics appears to be unsafe for women". This line has in fact lead to an unnecessary caution and warning been given to the then Head of the Department Dr. Prahlad Kumar by the Registrar vide letter No.05/R/252/2016 dated 31-03-2016, informing him that Economics Department does not seem to be sensitive towards women etc. Since CCASH Report did not mention anything against Dr. Prahalad Kumar is his individual capacity nor against the Economics Department, the Honorable Vice-Chancellor upon the representations of Prof. P. Kumar dated 08-04-2016 and 29-07-2016 had withdrawn the aforesaid letter by another letter No. 05/R/692/2016 dated 02-09-2016. The Executive Council after a long deliberation on the issue unanimously approved the action taken by honorable Vice-Chancellor and asked the University authorities to incorporate the letter in the proceedings of the Executive Council.

> The report of the CCASH Committee dated 05-10-2016 was also presented in Executive Council. The Council unanimously accepted the CCASH Report. Some members also questioned as to why some action has not been recommended for bringing a case for disciplinary action against Deepshikha Sonker who has been leveling false and fictitious allegations against senior and reputed teachers of the Economics Department and university functionaries including then Head and such an act by the lady teacher is bringing disrepute to the Department and to the University. Honorable Vice-Chancellor on this informed the Council that as the present case is under consideration in the honorable High Court, it would not be proper to take any decision till the case is finally decided there.

University of Allahabad e-mailed on 8th December, 2016 the AUTA's demand dated 7th November, 2016 along with relevant judgment (s) of the High Court & Apex Court seeking fresh directions from UGC.

UGC vide letter No. 1-15/2008 (SCT) dated 14th December, 2016 directed UoA to maintain the Roster register as per GOI norms of cadre wise. Accordingly, revised roster was prepared following the pattern of other Central Universities i.e. Hyderabad Central University, Delhi University & BHU by the Roster Committee formed by the approval of Vice-Chancellor vide Order No.05/R/895/2016 dated 2nd December, 2016 with both internal as well as external members, Committee of Dean's in its meeting dated 13th December, 2016 resolved that the proposed Roster of person with Disabilities (PWD), Social category should be placed before Academic Council for consideration. Academic Council of 14th December vide resolution no. 39/27 accepted the proposed Roster.
