Maternity Leave may also be granted in case of miscarriage, including abortion, subject to the condition that the total leave granted in respect of this to a woman teacher in her career is not more than 45 days, and the application for leave is supported by a medical certificate.
    - (ii) Maternity leave may be combined with any earned leave, half-pay leave or extraordinary leave, but any leave applied for in continuation of the maternity leave may be granted if the request is supported by a medical certificate.

As per clause 8.4 IX. (Child-care Leave) of UGC Regulation 2018, is quoted as under :-

Woman teachers having any minor child/children may be granted leave up to a period of two years for taking care of the minor child/children. The child-care leave for a maximum period of two years (730 days) may be granted to the woman teachers during entire service period in lines with the Central Government woman employees. In the cases, where the child-care leave is granted for more than 45 days, the University/College/Institution may appoint a part time/guest substitute teacher with intimation to the UGC.

The lines in at italic shall be replaced by following:-

In the case where the total leave is of more than 180 days, Guest faculty/Part Time contractual faculty could be appointed with the prior permission of the Competent Authority on the said matter shall always be reported to the UGC within 15 days.

Agenda No. 22/70 To consider the issue regarding separate written and skill test for overage applicants in the recruitment of non-teaching staff in the University.

> Rationale: There are many employees working in the University since 23/03/1998. (Many applicants were regularized by the High Court's Order). Since then, many employees retired so much so that out of 1381 non-teaching staff at present only 657 are working. Due to shortage of staff, many employees are employed on daily basis and they are working in various offices like Controller of Examinations, Finance Office, Registrar Office etc. No selection could be made due to non finalization of Cadre Recruitment Regulations.

Many of them went to Hon'ble High Court for regularization of services but the Hon'ble High Court clearly mentioned that no selection can be made without advertisement, but further acceded to the request of the employees that in case if these employees become overage, they shall be considered for appointment through an open advertisement and fair selection through a written test. (Judgment annexed as Annexure-A). Therefore the University is bound by the orders of the Hon'ble Court to consider their applications. Many of such candidates are above the age of fifty but are still working as daily wagers. The University desires to give them a chance to sit in the test which is being conducted by the University on the basis of advertisement No.AUNT/04/2021 dated 24.09.2021.

So, this matter is put before EC to decide upon their matter.

all faculty was enhanced to 10 years as per the EC resolution no 20/61 in the meeting dated 26.02.2021. But the benefit cannot be extended in retrospect from 06.08.2020. In his letter dated 29.08.2022, Prof. Pandey has claimed that he is on deputation upon which it is stated that he cannot be given deputation because he was initially granted lien of 3+2 years. The Vice Chancellor in her magnanimity extends his lien for a period of 2 years, provided the lien fee of the granted period of two years w.e.f. 06.08.2020 to 05.08.2022 is paid to the University at the 11% rate as prescribed. He is not adjunct faculty as per the ordinance of University of Allahabad. (Ref: Ordinance XIII: Appointments to Chairs and of Emeritus Professors and Adjunct Faculty).
