Resolution No.01/74(i) Registrar apprised the Executive Council about the writ petition filed by Dr. Deepshikha Sonkar in which inter alia grounds were stated for alleged breach of principles of natural justice. The Executive Council deliberated on the issue and came to a conclusion that order dated 28.03.2023 issued by the Registrar upon resolution No. 07/73 of Executive Council meeting dated 23.03.2023 is to be recalled as there is a procedural lapse. The salary of Dr. Deepshikha is to be released. As to the future course of action, it was further resolved that de-novo disciplinary proceedings be initiated in the matter in accordance with law.



- (ii) The Hon'ble Chairperson apprised the Executive Council members that a show cause notice was given to Prof. Arun Kumar in this matter, in which he apologized for the incident and also apologized in front of the students, so this agenda is dropped. The Executive Council approved the same.
