I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the **December 2020 & June 2021 (merged session) National Eligibility Test (UGC-NET)**, you have been selected for award of fellowship under the scheme of National Fellowship for Other Backward Classes (NFOBC).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFOBC, i.e., **19.02.2022** (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for UGC-NET, you had already taken admission for M.Phil/Ph.D through regular and full time mode in a UGC recognized University / Institution. Accordingly, you are required to apply for fellowship not later than three months from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of National Fellowship for Others Backward Classes available at [www.ugc.ac.in](http://www.ugc.ac.in).

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at [https://www.ugc.ac.in/ugc\\_notices.aspx?id=2153](https://www.ugc.ac.in/ugc_notices.aspx?id=2153)).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ugcnet.nta.nic.in>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
