### Legal Awareness Programme in India

This is informed that by referring notification dated 09/01/2024 regarding the promotion of outreach activity in the departments for sensitizing the students towards their duties and responsibilities within the society and community and to serve the citizenship training goal of education, the Faculty of Law, University of Allahabad, Prayagraj has organized a "Legal Awareness Programme" on the auspicious occasion of the "National Youth Day" 12th January 2024 at "Maheswari Prasad Inter College, Alamchand, Kaushambi and a lecture was delivered by the Prof. R.K. Chaubey, Dean, Faculty of Law, University of Allahabad University, Prayagraj at 11 AM onwards. Prof. R.K. Chaubey highlighted the numerous important aspects including the National Youth Day commemorating the birth anniversary of Swami Vivekananda, an eminent philosopher and youth icon. This day serves as an appropriate time to organize legal awareness programs targeting the youth population. Empowering young adults with knowledge of their legal rights and duties is essential for creating informed citizens who can actively participate in democracy and contribute towards nation-building. In his lecture, he motivated the students to educate and empower citizens about their legal rights and obligations and explored how the provisions of the Indian Constitution related to legal education, free legal aid, fundamental rights, fundamental duties, Directive Principles of State Policy (DPSP), etc. contribute to the success. He also emphasizes upon the importance of the right to equality, freedom of speech and expression, and protection against discrimination for respecting the rule of law, promoting harmony, and upholding the principles of social justice. Further, he recognizes the importance of legal education in ensuring a just and inclusive society for promoting governance and policymaking. Moreover, he also sensitized the students regarding the importance of sustainability, environmental protection, and the right to privacy. He emphasized the significance of Article 21A which mandates the right to education, including legal education, for all children between the ages of 6 and 14. Additionally, Article 39A promotes free legal aid and assistance, emphasizing the state's responsibility to ensure justice is accessible to all and is crucial for bridging the gap between marginalized individuals and the justice system. It ensures that the state provides suitable mechanisms for citizens, especially the economically weaker sections, to obtain legal aid and representation. In this programme total 155 students and 29 teachers of the college have actively participated, and appreciated the efforts made by the Prof. R.K. Chaubey, Dean, Faculty of Law, University of Allahabad. In the end, some students asked few questions which were answered accordingly and the programme was end in peaceful manner.
