- 4. The funds for data collection would be released in three instalments. The first instalment (50%) would be released at the beginning of data collection. The second instalment (25%) would be released upon completion of data collection work. The third instalment (25%) would be released upon submission of the final report.

- 5. The expenditure will be met from Budget Head MH 2401-130-10028 Professional Services of PM-Kisan Samman Nidhi during 2023-24 as authorized by the Farmers' Welfare Division.
