- 3. Rates shall be valid for (45) Forty five days from the date of opening of quotations.
- 4. Taxes shall be deducted as per rules.
- 5. Your rates should be inclusive of all taxes.
- 6. The payment of wages/ allowance and other benefits admissible to persons employed by the contractor for the job shall be the sole responsibility of the contractor as their employer under law.
- 7. The contractor shall be legally liable and responsible for any contravention of any legal requirement and consequent liability with regard to persons deployed by him in connection with the work assigned to him by the University.
- 8. In case of any dispute the decision of the Vice-Chancellor shall be final and binding on both the parties.
- 9. All the litigations will be subject to the jurisdiction of courts at Allahabad.
- 10. In case the work is not completed in stipulated time penalty of 5% of the value of work will be deducted from the contractors bill subject to maximum of 10% of total amount of bill.
- 11. Statutory deductions as per rule will be made from the bill.
