Terms & Conditions for utilizing the University's bus

- AC Bus facility is exclusively provided to wards of university's employees (Faculty & Non – Faculty) residing at University's premisses at Bank Road, Beli colony and MNNIT colony.
- Students, who wants to avail university transport facility, they are required to submit basic information in the prescribed format as enclosed herewith (Annexure-A) at the Transport Office, Situated at Tilak Bhawan, First Floor, Room No.9, Senate Campus, University of Allahabad.
- For more information, Students/Parents may contact to Shri Vijay Gupta- Section Officer (Transport Section) – 7839878003 or Visit transport office during working hours.
- To avail this bus facility, users/parents have to pay Rs. 2000/- p.m as transport charge. This payment shall be made through online/ card swipe machine (POS) available in the transport office. No cash payment is accepted. Parents must deposit transportation charge in advance latest by 5th of each month in the Transport Office. Bank details are mentioned below.
- Each ward availing of bus facility will be issued a bus pass displaying his/her name, parents name, class, section and bus no. by the transport section.
- The ward is expected to arrive at his pick-up point 5 minutes before the scheduled time.

- If a child wants to withdraw from this bus facility, 1 month's prior notice will have to be given by the parent in writing in the Transport Office.
- No diversion or extension will be made on existing routes.
- The list of students and their respective stops will be displayed in the bus as well as list of user will be available with attendant of the bus.
- University has resreve the rights to amend any clause / terms & condition/ withdraw this facility / revsie the monthly charges at any point of time & without assigning any reason.
