Our university wishes to promote a culture of amicable conflict resolution across all departments and establishments of the University. Mediation is an important component of Alternate dispute resolution. In this regard, Mediation and conciliation project committee (MCPC), Supreme Court of India, has agreed to conduct a 5 day (40-hour) Mediation Training Program on our campus in the month of July 2026 for a batch of 40 participants comprising faculty members and senior administrative staff.

In furtherance of the vision of our Hon'ble Vice-Chancellor towards creation of a dispute resilient institution, such training will also foster a collaborative problem-solving environment in the University in line with the Mediation Act 2023. It will also help us to contribute to the mediation system of the country. It may also lead to an opportunity of being appointed as mediators in the University or in the larger alternate dispute resolution system. The details of the Training Program are as follows-
