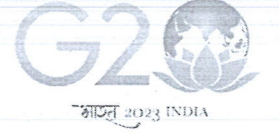

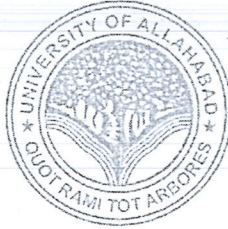
- (i) Mere eligibility will not entitle any candidate to be called for interview. The short listing of the candidates to be called for interview shall be done as per UGC Regulations, 2018 and University can adopt its own procedure for shortlisting in case of large number of candidates for single post.
- (ii) The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned in UGC Regulations, 2018 are permissible, based only on the qualifying marks without including any grace marks.
- (iii) The initial tenure of the appointee will be of 01 year from the date of appointment and may be extended further on satisfactory performance review and reappointing him/her on contract basis.
- (iv) All the fixed emolument, selection procedure and benefits will be subject to the *UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018, clause 13.*
- (v) Only matriculation/SSC certificate/pass certificate issued by the concerned educational board will be considered as proof of date of birth. No other document will be accepted for verification of date of birth.
