- (i) The candidates seeking engagement as Faculty are required to attend the walk-in-interview at the new building of the Faculty of Law on 01-09-2025 alongwith application form, original documents and self attested copies of all relevant documents.
- (ii) The application form can be downloaded from the website of the University of Allahabad [www.allduniv.ac.in](http://www.allduniv.ac.in).
- (iii) **The candidate must enclose the self-attested photocopies of the mark-sheets, certificates/degrees/Transitions ID (Fee Receipt) and other relevant documents with their application form.**
- (iv) Reservation for SC, ST, OBC,EWS and PwBD shall be applicable as per UGC Guidelines and GOI Rules.
- (v) The remuneration payable to the Faculty shall be a fixed amount of Rs. 45,000/- per month & Professional Experts shall be paid @Rs. 1,500/- per lecture subject to maximum of Rs. 50,000/- per month.
- (vi) The engagement of the Faculty is purely temporary (self-finance) basis up to 31<sup>st</sup> of May 2026 or engagement of full scale faculty on contractual basis, whichever is earlier.
- (vii) No queries will be entertained in this respect.
