GENERAL INSTRUTIONS

- i. The recruitment will be in accordance with the UGC Regulations, 2018 and any specific guidelines issued by the UGC from time to time up to the date of issue of this employment notification.
- ii. Mere eligibility will not entitle any candidate to be called for interview. The short listing of the candidates to be called for interview shall be done as per Appendix-II-Table: 34 of UGC Regulations, 2018.
- iii. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned in UGC Regulations, 2018 are permissible, based only on the qualifying marks without including any grace marks.
- iv. In the earmarked faculty positions the candidates must ensure that they have research and publication in the specialized area as desired. The research paper other than in specialized area will not be counted.
- v. The initial tenure of the appointee will be for one academic session (for a maximum period of 11 months) from the date of appointment, and may be extended for maximum of two subsequent academic sessions (for a maximum period of 11 months from the date of reappointment for each academic session) subject to the academic performance review and reappointment on contract basis at the end of each academic session with the approval of the competent authorities. No claim can be made for any permanent position at the University of Allahabad.
- vi. The fixed remuneration of faculty shall be Rs 57,700/-per month. The selection procedure will be subject to the UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018, clause 13 and as per University of Allahabad rules and guidelines applicable from time to time.

In accordance with the UGC Regulations, 2018, as amended from time to time, including amendments, applicants applying for the post of Assistant Professor must submit a certificate in the prescribed format from the concerned University to the effect that their Ph.D. degree is in compliance with relevant UGC Regulations for award of Ph.D. degree.
- ix. Applicants who have been awarded Ph.D from foreign Universities should enclose "Equivalence Certificate" issued by Association of Indian Universities, New Delhi. without which their candidature will not be considered and application will summarily be rejected.
- x. <u>Candidates belonging to SC/ST/OBC/EWS category should submit proper caste certificate as per the proforma of Government of India. The certificate shall not be more than 06 months old in case of SC/ST/OBC/EWS.</u>
- xi. <u>Candidates belonging to OBC category, but coming in creamy layer will not be entitled to the benefits of reservation and shall have to apply as General Category candidate.</u>
- xii. <u>Candidates belonging to EWS category should submit proper certificate as per the proforma of</u> Govt. of India.
